Comments received after this time will be treated as contemporaneous comments.

Contemporaneous Comments: During the meeting, the Committee Chair or designee will announce the opportunity to make public comments and identify the cut off time for submission. Please email your comments to district@sgvmosquito.org, write "Public

Once the public comment period is closed, all comments timely received will be read aloud at the meeting (not to exceed three minutes at staff's cadence).
