Comments received after this time will be treated as contemporaneous comments.

**Contemporaneous Comments:** During the meeting, the Committee Chair or designee will announce the opportunity to make public comments and identify the cut off time for submission. A short recess (generally less than 10 minutes) will take place during the time public comment is open to allow the comments to be collected.
